A. SUBMISSION REQUIREMENTS:

A submission of a specific-use permit to the Building Department shall consist of:

- Application packet including an application form and a signed copy of the submission requirements.
- A \$150 application fee.
- Required drawing(s) (see drawing requirements).

B. APPROVAL PROCESS:

- Submit a reproducible drawing(s) with an application to the Building Department, Freeport City Hall (200 West 2nd Street). Submitting the drawing(s) for review before the application deadline is encouraged in order to allow staff adequate time to review the submittal.
- Interdepartmental staff review (Site Review Committee) is conducted.
- Staff comments are returned to the owner or owner's representative.
- The corrected reproducible(s) is submitted to the Zoning Administrator and the case placed on the Planning and Zoning Commission's agenda for the appropriate
- Written notice of the public hearing before the Planning and Zoning Commission for the Specific-Use permit will be sent to owners of real property lying within Two Hundred feet (200') of the property upon which the Specific-Use permit is requested, as measured from the subject property inclusive of streets and rightsof-way. This notice will be given not less than Ten (10) days before the public hearing to such property owners as the ownership appears on the last approved
- A public hearing will be held by the Planning and Zoning Commission

(NOTE: THE PROCEDURE CONTINUES ONLY IF AN APPEAL IS

- An applicant may appeal the decision of the Planning and Zoning Commission to the City Council by filing an appeal in writing to the Building Department within Fifteen (15) days after the public hearing by the Planning and Zoning
- A public hearing is scheduled before the City Council. The Council may uphold, modify, or reject the decision of the Planning and Zoning Commission.

C. ADDITIONAL NOTES:

Note 1:

Application Withdrawal – Any request for withdrawal of an application must be submitted in writing to the Building Secretary. Once a request for a conditional use permit has been advertised and notification of the public hearing mailed, such request must be placed on a public hearing agenda whereby the appropriate body will consider and act on the request for withdrawal of the application at that time. The Planning and Zoning Commission is under no obligation to grant a request for withdrawal of the application, and may still act on the request as originally submitted. It should be understood that there will be no refunds.

Note 2:

Application Presentation – At the applicable Planning and Zoning Commission public hearing, an applicant shall have Fifteen (15) minutes to make a formal presentation of the project proposal. Due to the size and arrangement of the City Council Chambers, tripod-mounted opaque renderings generally prove to be an effective means of presentation. the use of slides is another means of visual aid for project presentations. the applicant shall assume full responsibility for providing a properly prepared and compatible slide carousel to staff prior to the public hearing. The use of transparencies on an overhead projector is another effective means of material presentation. If additional equipment is needed, it shall be the applicant's responsibility to provide or make the necessary arrangements.

Note 3:

Additional Information Submitted – Only the information which has been presented by the applicant at the Planning and Zoning Commission public hearing will be presented to the City Council at an appeal. Any additional information presented to the City Council which has not been previously submitted to and reviewed by the Planning and Zoning Commission will be referred by the City Council back to the Planning and Zoning Commission which may cause delays in action by the City Council.







ORDINANCE NO. __2014-2068

AN ORDINANCE OF THE CITY OF FREEPORT, TEXAS, CONTAINING A PREAMBLE; CONTAINING FINDINGS OF FACT AND CONCLUSIONS OF LAW; AMENDING THE COMPREHENSIVE ZONING ORDINANCE OF SAID CITY TO PERMIT THE SPECIFIC USE OF LOTS 2 THROUGH 8, VELASCO HEIGHTS ANNEX, FRONTING ON ZAPATA STREET, WITHIN THE CORPORATE LIMITS OF SAID CITY, AS A CHURCH TO BE OPERATED BY CHRIST COMMUNITY CHURCH OF BRAZOSPORT, INC., UNDER CERTAIN CONDITIONS THEREIN SPECIFIED; CONTAINING A SEVERANCE CLAUSE; AND PROVIDING THAT THIS ORDINANCE SHALL TAKE EFFECT AND BE IN FORCE FROM AND AFTER ITS PASSAGE AND APPROVAL.

WHEREAS, the City of Freeport, Texas, hereinafter sometimes called "the City", is a "Home Rule City" and a "Home Rule Municipality" lying and situated in Brazoria County, Texas, as described in and defined by Section 5, Article XI of the Constitution of Texas and Section 1.005 of the Local Government Code of Texas, respectively; and,

WHEREAS, Subchapter A of Chapter 211 of the Local Government Code of Texas and Item (g) of Section 3.07 of the Home Rule Charter of the City authorizes the City Council thereof to adopt the provisions of this Ordinance; and,

WHEREAS, the City Council of the City has determined and do here now declare that the adoption of this ordinance is necessary to the health, safety and general welfare of the inhabitants of the City and conforms to the comprehensive zoning plan of the City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FREEPORT, TEXAS:

SECTION ONE -- Findings of Fact and Conclusions of Law.

The City Council of the City makes the following findings of fact and conclusions of law, viz:

First, that all public hearings required by the Zoning Enabling Act of the State of Texas, now codified as Chapter 211 of the Local Government Code, and the present Comprehensive Zoning Ordinance of the City, codified as Chapter 155 of the Code of Ordinances of the City and hereinafter called "the Zoning Ordinance", were conducted in the manner and at the time required by said Code and the Zoning Ordinance.

hereinafter called "the Zoning Ordinance", were conducted in the manner and at the time required by said Code and the Zoning Ordinance.

Second, that not less than fifteen (15) days prior to the date of such hearings, a public notice thereof was published once in the Brazosport Facts, a newspaper of general circulation in and the official newspaper of the City, stating the time and place of such hearings.

Third, that not less than ten (10) days before the date of such public hearings, written notice of the application for the below mentioned Specific Use Permit was sent to all owners of real property located within the below described real property for which such permit is sought and within two hundred (200') feet from such property.

Fourth, that after giving due regard to the nature and condition of all adjacent uses and structures, the City Council of the City is of the opinion of that such proposed use conforms to the requirements and intent of the Zoning Ordinance and the Comprehensive Plan of the City; that the conditions herein below attached to the granting of such permit are necessary to the public interest; and that the proposed use under such conditions will not, under the circumstances of this particular case, constitute a nuisance or be detrimental to the public welfare of the community.

Fifth, that the health, safety, morals and general welfare of the inhabitants of the City will best be served by the adoption of this ordinance and the granting of the Specific Use Permit hereinafter mentioned.

SECTION TWO--Comprehensive Zoning Ordinance Amended and Specific Use Permit Granted.

The Zoning Ordinance is hereby amended and a Specific Use Permit is hereby granted with respect to the following described real property in the City of Freeport, Texas, to-wit:

Lots 2 through 8, Velasco Heights Annex, in the City of Freeport, Brazoria County, Texas, according to the map or plat of said annex recorded in the office of the County Clerk of said county,

fronting on Zapata Street, herein "the premises", which is owned by the FREEPORT CHRISTIAN CENTER, hereinafter "the owner", to authorize the use of the premises as a church to be operated by the owner, which is a non-profit corporation organized and existing as such under the laws of the State of Texas, herein "the Permitee", under the following terms and conditions, viz:

First, all parking between 7:00 a.m., and 7:00 p.m., shall be offstreet; all storage must be in an on-premises building; the premises must
be available for inspection by the City's Building Official at all times;
and any activities other than those of a church and those permitted in a
C-2 Zoning District by the Zoning Ordinance must be approved by a
concurrent vote of a majority of the members of the City Council and the
Planning Commission taken at any regular or special meeting thereof at
which a quorum of each body is present. The term "activities of a church"
means activities which are reasonably related to the use of the premises
for church meetings, fellowships, Christian entertainment and religious
worship by the members of the Permitee and its invitee.

Second, the Permit herein granted shall automatically terminate if the Permitee (a) ceases to be the owner, or (b) ceases, for thirty (30) consecutive days, to use the premises for the activities of a church as herein defined or any other use hereafter authorized as provided above in Item One.

Third, this permit may also be terminated by the City Council for a violation of any provision of Item First of this Section, or any amendment hereto, or if the Permitee leases or rents, for more than three (3) consecutive days, any portion of the premises to a third party or parties. Termination by the City Council shall be upon the affirmative vote of a majority of the members present and voting at any regular or special meeting thereof held after at least ten (10) days prior written notice sent by certified mail, return receipt requested and addressed to the Permitee at the premises, specifying the particular violation or violations. Any decision of the City Council thereon shall be entered upon the minutes of such meeting and shall be final and non-appealable.

SECTION THREE--Severance Clause.

In the event any section or provision of this ordinance is found to be unconstitutional, void or inoperative by the final judgment of a court of competent jurisdiction, such defective provision, if any, is hereby declared to be severable from the remaining sections and provisions of this ordinance and such remaining sections and provisions shall remain in full force and effect.

SECTION FOUR--Effective Date.

This ordinance shall take effect and be in force from and after its passage and approval.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FREEPORT, TEXAS, DESIGNATING ASSISTANT CITY MANAGER GIBERT ARISPE TO ACT FOR AND ON BEHALF OF THE CITY OF FREEPORT IN DEALING WITH THE TEXAS GENERAL LAND OFFICE FOR THE PURPOSE OF APPLYING FOR STATE ASSISTANCE TO CLEAN AND MAINTAIN THE PUBLIC BEACH.

ON THIS Monday, June 16th, 2014, the City Council of the City of Freeport, Texas, convened in a regular meeting, notice of the convening of which was duly posted in accordance with the Texas Open Meetings Act, when among other business the City adopted the following resolution:

A resolution in connection with application of Bryan Beach for State assistance in cleaning, and maintaining public beach for the period of September 1, 2014 to August 31, 2015.

WHEREAS, the Beach Maintenance Fund Program under the administration of the Texas General Land Office, Austin Texas, requires each city making application for assistance in cleaning and maintaining public beaches to submit supportive documents: and,

WHEREAS, each city shall enter a resolution directing Gilbert Arispe to make application for funds and vesting that official with full authority to act for purpose of the program.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FREEPORT, BRAZORIA COUNTY, TEXAS;

That Bryan Beach apply for state assistance in cleaning and maintaining the public beach under Section 61.076, Natural Resources Code; and

That Gilbert Arispe shall be vested with full authority to act for purpose of the program.

That any and all fees collected by reimbursement shall be utilized only and specifically for the program of beach maintenance.

Attached is our bid to serve as depository for the City of Freeport for the period June 1, 2014–September 30, 2014 and thereafter until a successor depository is selected and qualifies.

Please find enclosed the following documents:

- A resolution passed by the Board of Directors authorizing the Bank to pledge securities equal to the total amount of the City of Freeport's Funds on deposit as required by law.
- 2. A statement of financial condition of Texas Gulf Bank, N.A. that includes the amount of paid up capital stock and permanent surplus.
- 3. A sample account analysis format. (Exhibit A)
- A. We agree to pay the 91-day Treasury bill yield rate on all collected funds in demand accounts floating monthly. On Time accounts, we will pay Texas Gulf Bank's Public Fund CD rate effective at the time of purchase for the term specified by the City.
- B. Normal demand deposit account services shall be provided in the name of the City of Freeport and will include the following:
 - Credit all deposits to such accounts and give immediate credit to government checks, ACH transactions, wire transfers and all other checks based on the Bank's availability schedule. All deposits received before the Bank's established deadline will be credited daily.
 - Payment of properly drawn checks against accounts.
 - Provide checks, deposit slips, and endorsement stamps printed to the City's specifications at cost.

- 4. Stop payments will be accepted on verbal instructions from the City Manager or his assignee with follow-up written confirmation within twenty-four (24) hours.
- C. Payment for Services: We will bill or accept direct payment for services at the unit prices indicated on the attached worksheet. (See Exhibit A)

Insufficient Charges and Overdraft Float Charges will be assessed on a per account basis regardless of other account balances. (See Exhibit A)

D. Investment Services:

We agree to arrange for the purchase of securities as directed by the City Manager. A safekeeping receipt from the Bank's correspondent bank, presently TIB-The Independent Bankers Bank, will be furnished. We will provide a monthly report showing the market value.

E. Other:

We agree to offer *Texas Gulf Connection*, our internet banking solution and *Q-line* our automated phone system at no charge. Both products will assist the City with a variety of services including account balance information and transaction activity.

Our Remote Deposit Capture product will enable the City to make deposits of checks from City offices with an extended deposit deadline of 5:00. We also now offer Positive Pay, a risk management tool. More information about these products can be found on our website at www.texasgulfbank.com.
