There being a quorum with the Planning Commission, Mayor Garcia opened the Joint Public Hearing at 6:03 p.m.

Edward Garcia Chairman for the Planning Commission stated that they had no opposition to granting to Freeport Christian Center a Specific Use Permit to construct and operate a church on Lots 2-8, Velasco Heights Annex, fronting on Zapapta Street within the corporate limits of said City. There being no comments or questions from audience or staff, Mayor Garcia closed the Public Hearing at 6:05 p.m.

Consideration of approving Ordinance No. 2014-2068 granting to Freeport Christian Center a Specific Use Permit to construct and operate a church on Lots 2-8, Velasco Heights Annex, fronting on Zapata Street within the corporate limits of said City.

On a motion by Councilman McDonald, seconded by Councilwoman Loeza, with all present voting "Aye", Council unanimously approved Ordinance No. 2014-2068 granting to Freeport Christian Center a Specific Use Permit to construct and operate a church on Lots 2-8, Velasco Heights Annex, fronting on Zapata Street within the corporate limits of said City.

Joint Public Hearing: The City Council and the Planning Commission of said City will conduct a Joint Public Hearing an amendment to Exhibit A (layout plan) of the Specific Use Permit granted to Mr. Eric Hayes to construct an RV park on Brazosport Boulevard, BCIC Division 14, Lots 92 & 93, Freeport Texas.

Mayor Garcia opened the Joint Public Hearing with the Planning Commission at 6:06 p.m.

Edward Garcia Chairman for the Planning Commission stated that they approved the amendment to Exhibit A (layout plan) of the Specific Use Permit granted to Mr. Eric Hayes to construct an RV park on Brazosport Boulevard, BCIC Division 14, Lots 92 & 93, Freeport Texas.

Councilman McDonald asked why a Joint Public Hearing was held on an amendment to a Specific Use Permit. Mr. Shaw answered that it was a request change to the Specific Use Permit. Mr. Eric Hayes was changing the lot size to 116 to 190 RV spaces and requesting the entrance from Hwy. 288 instead of Zapata Street. Mayor Norma Garcia said she received calls today stating that the City had done a beautiful entry way to the city and their concerns were that he would neglect the RV park like his other rental properties in the City. Mayor Garcia recalls two other proposed parks were declined in the City because of neglect of premises.

Councilman Bolton was firm on the RV construction and code and was critical to him that things are taken care of, not interested in having an entrance on Hwy 288. He reiterated that Council had declined two other businesses of RV parks because of neglect of premises.

There being no more comments or questions from audience, Mayor Norma Garcia closed the Joint Public Hearing at 6:20 p.m.

RESOLUTION NO. 2014-2441

A RESOLUTION OF THE CITY OF FREEPORT, TEXAS, CONTAINING A PREAMBLE; MAKING FINDINGS OF FACT PURSUANT TO SECTION 26.001 OF THE TEXAS PARKS AND WILDLIFE CODE WITH RESPECT TO RELOCATING A PORTION OF RIVERSIDE PARK AND ALL OF STEPHEN F. AUSTIN PARK AT A NEW LOCATION WITHIN THE CORPORATE LIMITS OF THE CITY TO BE CHOSEN BY THE CITY COUNCIL AND AT WHICH A MODERN SPORTS COMPLEX WILL BE DEVELOPED; CONTAINING A SEVERANCE CLAUSE; PROVIDING THAT THIS RESOLUTION SHALL TAKE EFFECT AND BE IN FORCE FROM AND AFTER ITS PASSAGE AND ADOPTION; AND PROVIDING THAT THE ORIGINAL OF THIS RESOLUTION SHALL BE MAINTAINED BY THE CITY SECRETARY IN THE PERMANENT RECORDS OF SAID CITY.

WHEREAS, the City of Freeport, Texas, hereinafter sometimes "the City," is a "Home Rule City" and a "Home Rule Municipality" lying and situated in Brazoria County, Texas, as described in and defined by Section 5, Article XI of the Constitution of Texas and Section 1.005 of the Local Government Code of Texas, respectively; and,

WHEREAS, Sections 51.072 of the Local Government Code, Section 26.001 of the Parks and Wildlife Code and Section 2.01 and Item (u) of Section 3.07 of the Home Rule Charter of the City of Freeport authorize the City Council thereof to adopt the provisions of this Resolution; and,

WHEREAS, the City Council of the City has determined and do here now declare that the adoption of this resolution is necessary to the health, safety and general welfare of the inhabitants and persons using the public parks of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FREEPORT, TEXAS:

First, the City Council of the City of Freeport, Texas, makes the following findings of fact:

- (1) The public hearing required by Section 26.001, et seq., Texas Parks & Wildlife Code, was conducted and notice thereof was given in the manner and for the time required.
- (2) In the plat of the Velasco Townsite recorded in Volume 32, page 14 of the Deed Records of Brazoria County, Texas, defines Riverside Park to be a public park.
- (3) The Riverside Park located north of a westerly extension of the street shown on the plat of the Velasco townsite as Avenue C is improved for and has been used by the public for a number of years as a park and recreation area containing multiple baseball fields but it is too small to be a location for a modern sports complex. At an election held on May 10, 2014, the sale of such portion of Riverside Park was approved by a majority of those voting at such election. This sale may provide a portion of the funds needed for the development of a major sports complex at

a different location and such use of such funds would be reasonable and prudent. That portion of Riverside Park located south of such westerly extension is the site of the Velasco Community House and a playground for children and its use for such purposes will be continued.

(4) Finding an alternative site consisting of vacant land of sufficient acreage on which to construct a major sports complex which would include commensurate of baseball fields presently located at Riverside Park located north of a westerly extension of the street shown on the plat of the Velasco townsite as Avenue C constitutes a feasible and prudent alternative to the continued use of either Stephen F. Austin Park or the continued use of that portion of Riverside Park located north of a westerly extension of the street shown on the plat of the Velasco townsite as Avenue C as a location for baseball fields.

Second, the City Council finds that there is no feasible and prudent alternative to discontinuing the use of that portion of Riverside Park located north of a westerly extension of the street shown on the plat of the Velasco townsite as Avenue C as a park or recreation area, including its current use for baseball fields, if a new location of sufficient acreage is found on which to construct a major sports complex containing not less than the current number of baseball fields.

Third, in the event any section or provision of this resolution is found to be unconstitutional, void or inoperative by the final judgment of a court of competent jurisdiction, such defective provision, if any, is hereby declared to be severable from the remaining sections and provisions of this ordinance and such remaining sections and provisions shall remain in full force and effect.

Fourth, this resolution shall take effect and be in force from and after its passage and adoption.

Fifth, the original of this resolution, after execution and attestation, shall be maintained by the City Secretary in the permanent records of the City.
