Mayor Brooks Bass called the meeting to order at 6:00 p.m.

Citizen lifesaving award

Freeport Police Chief Ray Garivey presented two Citizen Lifesaving Awards to Randy Wilkinson and Brad Stevenson.

Employee of the month

City employee Darla Autrey was presented with a certificate recognizing her as Employee of the Month for November 2019.

Citizen's Comments

Desiree Pearson asked is the pothole on Caldwell and Ave A could be repaired, and not have just a little something placed to temporarily fix the problem.

CONSENT AGENDA:

Consideration and possible action on the approval of City Council meeting minutes from November 26, and December 2, 2019.

Consideration and possible action for EMS service agreement for EMS billing

On a motion by Councilman Yates, seconded by Councilman Green, with all present voting "Aye", Council unanimously approved the Consent Agenda.

REGULAR SESSION

Consideration and possible action of approving the cost of proposed outriggers to the Mystery Boat.

Parks Director Kim Townsend presented to Council the proposed contractor SWS and bid of \$12,500.00 for the repair of the outriggers on the Mystery Boat. Mr. Lackey with SWS explained the reconstruction and updating of the Mystery Ship. Councilman Green said that he feels the \$12,500.00 seems very costly. Nicole Mireles asked Mr. Lackey if he had a location to do the repairs to the Mystery Boat. Mayor Bass asked Fire Chief Motley if he would be available for fire suppression.

On a motion by Councilman Yates, seconded by Councilwoman Loeza with all present and voting 4 to 1. Council approved the cost of repairs of the outriggers. Councilman Green voted no.

Consideration and possible action approving purchase of Watchguard.

Assistant City Manager Stephanie Russell presented to Council the purchase of a dash camera system and software for the Freeport Police Department patrol fleet. Ms. Russell said that this purchase is \$77,640.00 There is a grant that was awarded which will pay for the purchase. Per the City's purchasing policy since the purchase is over \$50,000.00 the purchase must come before Council. Mayor Bass said

this is budget neutral. David Fernandez from the Freeport Police Department told Council the dash camera system has not be upgraded for about ten years. He said that the current system is failing.

On a motion by Councilwoman Loeza, seconded by Councilman Green with all present and voting "Aye" council unanimously approved the purchase of dash camera system and software from Watchguard.

Consideration of approving and awarding the bid for contract for Lift Station No. 5 & 13 rehab and sewer line replacement

City Manager Tim Kelty presented to Council the approval of the bid from C & A Construction, LLC. This bid is for the rehab of Lift Station's No. 5 & 13, and the sewer line replacement project. This project was designed by Freese and Nichols. Sealed bids were received and opened on November 26, 2019. from Sorrell Construction, Matula & Matula Construction Inc., and C & A Construction, LLC. Freese and Nichols recommends that the City award the contract to C & A Construction, LLC. Mayor Bass asked if the contracts going forward if there will be language that defines start and end time.

On a motion by Councilman Yates, seconded by Councilman Cain with all present and voting "Aye" council unanimously approved, awarding the bid for contract for Lift Station No. 5 & 13 rehab and sewer line replacement to C & A Construction, LLC.

Consideration and possible action regarding the report of Charter Review Commission recommendations to place items on Charter Review Election Ordinance

City Manager Tim Kelty presented to Council the report from the Charter Review Commission recommendations. There is a total of eight recommendations to be presented to Council.

(1) Section 3.01 (b) (d) Number, Selection and Term 5.10 Limitation on Consecutive Terms of Office Recommend amending the Charter "from two-year terms, to three-year terms for no more than two consecutive years for Mayor and City Council."

On a motion by Councilwoman Loeza, seconded by Councilman Yates with all present and voting "Aye" Council unanimously approved Section 3.01 (b) (d) and 5.10 to be placed on the May 2020 ballot.

(2) **Section 3.01 (f)** Recommend amending the Charter to include "Election Dates as standardized by State Law."

On a motion by Councilman Yates, seconded by Councilman Cain with all present and voting "Aye" Council unanimously approved adding Section 3.01 (f) to be placed on the May 2020 ballot.

(3) Section 3.04 Compensation Recommend amending the Charter that the "Mayor shall receive a monthly compensation of \$400.00 and Council to receive a monthly compensation of \$200.00. And the Mayor and Council shall receive an additional \$50.00 payable monthly for each posted meeting of the City Council that they attend."

On a motion to disapprove by Councilman Green, seconded by Councilman Yates with all present and voting "Aye" Council unanimously approved the rejection of doubling the Compensation that was recommended by the Charter Review Commission and not place the item on the May 2020 Ballot.

(4) Section 3.07 Powers of the City Council Recommend amending the Charter to "allowing the City Council to adopt, modify and carry out all plans proposed by the Planning Commission."

On a motion by Councilwoman Loeza, seconded by Councilman Yates with all present and voting "Aye" Council unanimously approved amending Section 3.07 to be placed on the May 2020 ballot.

(5) **Section 4.06 City Attorney** Recommend amending the Charter to "eliminate" the requirement that the City Attorney must be a qualified voter in Brazoria County, Texas.

On a motion by Councilwoman Loeza, seconded by Councilman Cain with all present and voting 4 to 1 Council approved amending Section 4.06 to be placed on the May 2020 ballot. Mayor Bass voted no.

(6) **Section 11.011 Selection of Newspaper for Publication** Recommend amending the Charter to "require that every ordinance or resolution adopted by the City Council, shall be published in accordance with State Law."

On a motion by Councilman Yates, seconded by Councilman Green with all present and voting "Aye" Council unanimously approved amending Section 11.011 to be placed on the May 2020 ballot.

(7) **Section 1.02 Boundaries** Recommend amending the Charter to "recognize the city boundaries as they currently stand and as may be amended in the future."

On a motion by Councilman Cain, seconded by Councilman Yates with all present and voting "Aye" Council unanimously approved amending Section 1.02 to be placed on the May 2020 ballot.

(8) **Section 3.10 Rules of Procedure** Recommend amending the Charter to "allowing the recordation of adopted ordinances and resolutions to be permanently maintained by electronic means."

On a motion by Councilwoman Loeza, seconded by Councilman Cain with all present and voting "Aye" Council unanimously approved amending Section 3.10 to be placed on the May 2020 ballot.

Consideration of approving Ordinance No. 2019-2591 to extend the industrial district contract

City Manager Tim Kelty presented to Council proposed Ordinance No. 2019-2591. An extension of the industrial district contract with DOW Chemical, BASF and Brock Stratton Ridge. He said that this is a joint agreement with the cities of Lake Jackson, Clute, and Freeport. Mr. Kelty said that this is an extremely important revenue source for the City of Freeport. The original agreement expires in 2026 and that the proposed extension agreement with the ordinance will ensure the revenue until 2034. Mr. Kelty said that the City of Clute has already approved their agreement, and the City of Lake Jackson was presenting theirs on December 16, 2019 to Council for approval. Melanie Oldham asked with this new legislation does this mean that cities cannot annex an industry or business without permission. Mayor Bass said that this was not included in the final passing of the legislation. Councilwoman Loeza asked if the year 2033 was correct in the ordinance. Mr. Kelty asked Council that Ordinance 2019-2591 be amended to the year 2034.

On a motion by Councilwoman Loeza, seconded by Councilman Green with all present and voting "Aye" Council unanimously approved Ordinance No. 2019-2591 to extend the industrial district contract, with the amendment to the ordinance in SECTION 1 to the year 2034.

WORK SESSION:

Councilman Green said that Ave B in Ward C has just one speed limit sign. He asked if there are regulations to get more signs on this street. Ray Garivey said that even if there is no sign posted the speed limit is 30 MPH. Councilman Green said that a resident said that school buses and the transit bus drivers are the worst at speeding down this road. Councilman Green thanked the team that put the Senior Citizen luncheon together, he said it was very nice. He also said that 6th Street and Walnut there is a sink hole that needs to be repaired. Melanie Oldham asked what repairs were being done in Ward A. David Hoelewyn said this will start after the first of the year with the interlocal.

Councilman Cain asked Street Department Director David Hoelewyn if there were any updates on the repairs that we have going on. David Hoelewyn said that the County has one more block that they were going to stabilize today, but they had some repairs that had to be done to waterlines, those were lowered today. And they should be stabilizing tomorrow. He said that it will be after the first of the year before they can get on the asphalt.

Councilwoman Loeza asked about Ave I, she said that there is a bush that has grown out and when you are trying to turn out you cannot see. She asked David Hoelewyn if this is something he can trim or cut down. Nicole Mireles said that there are cars that are parked on the street to where you cannot get around. Councilwoman also thanked the committee that put the Employee Christmas party together, she said that it was lots of fun, and she really enjoyed it.

Councilman Yates said that he wanted to thank the City Employee that repaired the big hole in a street that was reported to him from an employee at CVS Pharmacy. He said he did not remember the street, but the repair was done.

City Manager Tim Kelty said that there a several projects that we are moving forward on. He said that elevator at City Hall, the repair will begin the week of December 30 and it will take about a week to get the repair complete. The final phase of the repair for the HVAC began today and that will be completed. Mr. Kelty also said that he wanted to recognize and thank the employees that put the employee Christmas party together. He said that everyone had a great time. He also announced that he will be gone from December 26-31.

Update on reports / concerns from Department heads

Street Department Director David Hoelewyn said that Munson Street was completed last Friday. He also said that the generator on Mystery Harbor is up and running.

Freeport Fire Chief Motley said that Actions from Lake Jackson asked how the City gets such a large crowd at our Sr. Citizen luncheon, he said that they were very impressed. He said that going into the New Year we have some new mandates for Emergency Management training. He also said that in January or February there will be discussion on the 1495 bridge construction.

Open session was closed at 7:07 pm and Council entered into Executive Session.

He also told Mr. Wong that he is the owner of the land, and the City wants to see this developed as much as he does. The Mayor said that he understands the deadline with TCEQ is January 31, 2020. Mayor Bass said that we are working hard. Mayor Bass said that Council had a very good discussion on the Consent Resolution.

Staff Recommendation:

Ratify the City Manager's approval of the City's windstorm & hail insurance policy renewal for 2020 as proposed by Victor Insurance for TWIA (Texas Windstorm Insurance Association).

Item Summary:

Victor Insurance has provided a Windstorm & Hail Proposal effective January 6, 2020. Victor Insurance works in conjunction with Texas Municipal League Intergovernmental Risk Pool. The coverage premium is \$80,214 annually. This amount will be reduced somewhat due to the removal of the demolished Community House at 1300 W. 2nd Street. That change has been noted on the Proposal Acceptance Form.

Background Information:

In order to ensure coverage beginning January 6, 2020, the City Manager executed the Proposal Acceptance Form in December. Ratification of this renewal is being brought to Council because the amount exceeds \$50,000. TWIA was the only windstorm insurance option presented by Victor Insurance this year; however, we have requested more options and more time for consideration of future renewal proposals.

Special Considerations

River Place Pavilion, Library and the Golf Pro-Shop are covered under a separate policy that renews next summer.

Financial Impact:

\$80,214 annual premium, based on total property values of \$10,676,644 which is less than last year's premium of \$83,678.





Title: FY2018-2019 Proposed Budget Amendment #7

Date: January 6, 2020

From: Stephanie Russell, Assistant City Manager/Finance Director

Staff Recommendation:

I recommend the following final budget amendment to the FY2018-2019 Budget.

Item Summary:

This proposed budget amendment offsets major expenditure overages by shortages or increased revenue based on actuals (unaudited) through the end of the fiscal year. Overall, the net impact to the General Fund is zero.

Background Information:

Below is a summary of each of the proposed changes.

- A. <u>Garbage Collection</u>: Per the City's solid waste contract, charges from Waste Connection automatically increase by 100% of the actual percentage change in the Consumer Price Index (CPI). This year's CPI adjustment was 1.55% Council previously increased the rates accordingly but the expenditures were not adjusted. Therefore; the Garbage Collection account is over by \$34,000.
- B. Golf Course: The golf course had major issues with its pump station and panel causing it to be replaced at the end of the year (\$26,350). Part of this expense was included in a prior budget amendment. Additionally, the Golf Course expended \$13,200 more in merchandise than expected due to customer demand.
- C. <u>Salary/Vacancy Savings</u>: Salary and benefit expenditures have been decreased across departments with substantial vacancy savings to offset the increase in expenditures.
- D. <u>Court Security</u>: Council approved an initial transfer and the creation of the Court Security fund in a prior budget amendment, however; after review of prior year expenditures, the actual amount due to the new fund is \$16,300 greater than originally estimated.
- E. <u>State Seized</u>: Council approved an initial transfer and the creation of the State Seized fund in a prior budget amendment, however; after review of prior year expenditures, the actual amount due to the new fund is \$9,300 less than originally estimated.
- F. <u>Utility Fund</u>: There were a couple of prior year expenditures that were not paid until this fiscal year. First, the City's annual payment to City of Oyster Creek for usage of their wastewater treatment plant was in arrears. The total of this debt was \$100,400 over budget.

Second, the September 2018 water consumption payment to Brazosport Water Authority was not paid until December 2018 (this fiscal year). This brought the account \$183,000 over budget. These expenditures have been offset by a \$283,400 transfer from the General Fund.

- G. <u>Beach Maintenance Fund</u>: The annual reimbursement from the GLO was increased by \$905, therefore; the revenues expenditures have been adjusted to reflect the new total. The net impact to the fund is zero.
- H. <u>Debt Service Fund</u>: The City paid an \$10,208 to close out an existing loan. This payment was not budgeted but is offset by Property Tax revenues. The net impact to the fund is zero.

ORDINANCE NO.2020-2592

AN ORDINANCE OF THE CITY OF FREEPORT, TEXAS, CONTAINING A PREAMBLE; CONTAINING FINDINGS OF FACTS; AMENDING THE BUDGET FOR THE FISCAL YEAR 2018-2019; CONTAINING SAVINGS CLAUSES; CONTAINING A SEVERANCE CLAUSE; AND PROVIDING THAT THIS ORDINANCE SHALL TAKE EFFECT AND BE IN FORCE FROM AND AFTER ITS PASSAGE AND ADOPTION.

WHEREAS, pursuant to the provisions of Subsection (a) of Section 102.007 of Chapter 102 of the Local Government Code and the provisions of Article 9 of the Home Rule Charter of the City of Freeport (hereinafter sometimes "the City"), the budget for the 2018-2019 fiscal year of the City was finally approved by the City Council, being the governing body thereof, by its Ordinance No. 2018-2554, read, passed and adopted on the 17th day of September, 2018, (hereinafter sometimes "the Budget"); and,

WHEREAS, Subsection (b) of Section 102.009 of the Local Government Code provides that, after final approval of the budget, the governing body of a municipality may spend municipal funds only in strict compliance with the budget, except in an emergency, but Section 102.010 of said Code provides that the provisions of Chapter 102 thereof do not prevent the governing body of such municipality from making changes in the budget for municipal purposes; and

WHEREAS, Subsection (c) of Section 102.009 of said Code provides that the governing body of a municipality may authorize an expenditure as an amendment to the original budget only in the case of grave public necessity to meet an unusual and unforeseen condition that could not have been included in the original budget through the use of reasonably diligent thought and attention; and,

WHEREAS, Section 9.16 of the City's Home Rule Charter provides that the budget may be amended and appropriations altered in accordance therewith in cases of public necessity, the actual fact of which shall have been declared by the City Council; and,

WHEREAS, the adoption of this ordinance and the amendments of the Budget is necessary for and in the best interest of the health, safety and general welfare of the inhabitants of the City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FREEPORT, TEXAS:

SECTION ONE (1): FINDINGS OF FACT

In connection with the amendment and revision of the Budget, the City Council of the City makes the following findings:

- (1) The amendments and revisions set forth in the Budget were the result of numerous public workshop meetings called and conducted in the manner required by the Texas Open Meetings Act, codified as Chapter 551, Government Code.
- (2) A public hearing was held on the Budget on September 18, 2017 and conducted in the manner required by Section 102.006 of the Local Government Code and the City's Home Rule Charter.
- (3) Notice of such public hearing was published in the Brazosport Facts, a newspaper of general circulation in and the official newspaper of the City in the manner and time required by Chapter 102 of said Code and the City's Home Rule Charter.
- (4) A grave public necessity exists and to meet an unusual and unforeseen conditions that could not have been included in the original budget through the use of reasonably diligent thought and attention and the Budget must be amended and revised with respect of the new or additional expenditures set forth in Exhibit "A" attached hereto and made a part hereof, such unusual and unforeseen conditions also being set forth in said Exhibit "A".
- (5) The proposed changes are set forth in Exhibit "A" attached hereto and made a part hereof.
- (6) All of the changes set forth in Exhibit "A" are for municipal purposes.
- (7) The several amounts stated in Exhibit "A" as the amended or revised expenditures are hereby appropriated to and for the objects and purposes therein named.
- (8) The contingent appropriations, as amended and revised in said Exhibit "A", do not exceed three (3%) percent of the total amended and revised budget appropriations reflected therein.
- (9) The amended and revised expenditures of the general fund and the debt service fund contained in the Budget, as amended by said Exhibit "A", do not exceed the resources of each fund, as amended and revised.

SECTION TWO (2):

The existing budget of the City of Freeport, Texas, for the fiscal year 2018-2019, as heretofore amended by Ordinance No. 2018-2563, read, passed and adopted on November 19, 2018; Ordinance No. 2018-2564, read, passed and adopted on December 17, 2018; and Ordinance No. 2019-2570, read passed and adopted on April 1, 2019; Ordinance No. 2019-2575, read, passed and adopted on June 17, 2019; Ordinance No. 2019-2578, read, passed and adopted on August 5, 2019; Ordinance No. 2019-2583, read, passed and adopted on September 16, 2019; and is hereby amended and revised as reflected in said Exhibit "A".

SECTION THREE (3):

As required by Subsections (c) and (d) of Section 102.009 of the Local Government Code, upon the passage and adoption of this ordinance, the amended and revised budget adopted hereby shall be filed with the City Secretary of the City to be maintained in the official records of the City, and a certified copy of this ordinance, with Exhibit "A" attached thereto, shall be filed by the City Secretary with the County Clerk of Brazoria County, Texas, and a copy sent to the State Comptroller of Public Accounts for the State of Texas.

SECTION FOUR (4):

Nothing contained in this ordinance shall cause any rights heretofore vested to be altered, affected or impaired in any way and all such rights may be hereafter enforced as if this ordinance had not been adopted.

SECTION FIVE (5):

In the event any section or provision of this ordinance is found to be unconstitutional, void or inoperative by the final judgment of a court of competent jurisdiction, such defective provision, if any, is hereby declared to be severable from the remaining sections and provisions of this ordinance and such remaining sections and provisions shall remain in full force and effect.

SECTION SIX (6):

This ordinance shall take effect and be in force from and after its passage and adoption.

READ, PASSED AND ADOPTED this 6th day of January, 2020.

Staff Recommendation: Staff recommends authorizing Freese and Nichols to move forward with this work.

Item Summary:

This action would authorize Freese and Nichols to proceed with the overall evaluation of the pump station north of the Old River and east of Velasco Blvd behind the City Service Center. This pump station has been plagued with issues over the years from failing pumps and motors to failing back up power. At a recent meeting, City Council has requested that we have the City Engineer to complete a thorough evaluation of the stations design and effectiveness, troubleshoot the system, and make any recommendations for improvement.

The proposed work is expected to take 30 days, and if authorized a report and recommendation should be ready in February. The cost for the evaluation is \$15,000.

Background Information: The station currently includes two motors and pumps with a capacity 12,500 GPM each. Included are two 20 diameter pumps and two 75 hp motors. The motors are less than 3-years old. One pump was originally built in the 1980's and rebuilt in 2017. The other pump was brand new as of 2018. The back-up generator installed new in 2017, runs on natural gas.

Financial Impact: The cost of this authorization is \$15,000.

SCOPE OF SERVICES

Project Understanding:

Freese and Nichols, Inc. (FNI) will perform an assessment on the stormwater pump station on N. Velasco Blvd. north of the river. FNI will assess the condition of the pumps, electrical equipment, and the site to determine what, if any, improvements are needed to increase reliability of the pump station. FNI will prepare a memo with recommendations for improvements, estimated costs, and a summary of the assessment.

Assumptions:

- 1. No capacity analysis will be performed as a part of this assessment.
- 2. City will provide record drawings and data on pumps, generator, and electrical gear

ARTICLE I

TASK A: PUMP STATION ASSESSMENT

A1. Pump Station Assessment

FNI will perform a site visit to assess the condition and reliability of the existing pump station. This will include evaluation of the following components:

- Two existing 12,500 gpm pumps
- Improvements necessary to install a 3rd smaller pump in empty slot
- Two motors
- Natural gas generator
- Electrical equipment
- Piping
- Paving, lighting, and other site items

FNI will provide a deliverable summarizing the analysis for each component, proposing recommendations as necessary, and provide an opinion of probable construction cost for any improvements.

Natural gas-powered pumps will be evaluated and discussed in the letter as an option to address reliability concerns.

Summary of Schedule

FNI is authorized to commence work on the Project upon execution of this Agreement and agrees to complete the services as follows:

If FNI's services are delayed through no fault of FNI, FNI shall be entitled to adjust contract schedule consistent with the number of days of delay. These delays may include but are not limited to delays in City or regulatory reviews, delays on the flow of information to be provided to FNI, governmental approvals, etc. These delays may result in an adjustment to compensation.
