Mayor Pro Tem Norma Garcia opened the meeting at 6:02 p.m.

## Consideration of approving the September 7th, 2010 Council Minutes.

On a motion by Councilwoman Kent, seconded by Councilwoman Mireles, with all present voting "aye", Council unanimously approved the September 7th, 2010 Council Minutes.

## Attending citizens and their business.

Jim Pirrung of 101 Dolphin Lane asked the Council to look into the history of the Golf Course green fees before raising fees; revenues went down. The Freeport Golf Course has a Friday Night Special which is very well attended.

Recognition of Heroic Actions from Freeport Police Officers: Assistant Chief Gus Flores, Officer David Fernandez, Officer Marcos Salinas, Officer Chris Bryant, and Fire Fighter Jessica Vandergrifft.

Chief Morrow presented a plague to the above officers for their heroic efforts and selfless actions. On August 8<sup>th</sup>, 2010, Freeport Police Officers: Assistant Chief Gus Flores, Officer David Fernandez, Officer Marcos Salinas, Officer Chris Bryant and Fire Fighter Jessica Vandergrifft responded to a call on 403 South Front Street, "Mitchell's Bait and Tackle" for a boating accident. Five people were in the water, one was unconscious and four were panic-stricken; they were not wearing life guards and were clinging to the capsized boat. They dove in the water, placed life vests on the victims and removed them from the water safely.

Presentation from the Freeport Lion Host donating \$12,000 to the Freeport Police Department for the purchase of a narcotic dog.

Freeport Lion Host Club Ist Vice President, Kristle Kersten and Chairwoman of the Fishing Fiesta presented a \$12,000 check to the Freeport Police Department for the purchase of a narcotic dog. Ann Johnson – 2nd Vice President thanked all the sponsors for their support.

Mayor Pro Tem Norma Garcia also member of the Freeport Lion Host Club thanked the Club for their donation.

## Presentation of Texas Parks & Wildlife Trail Grant for the wetlands area on Hwy 36.

City Manager Jeff Pynes advised Council and audience that the City was awarded \$199,898 to complete the wetlands along Highway 36 immediately South of the project. A sign at entrance, road entry and parking, 6' hiking trails around perimeter of the wetlands area, two 5' high observatory stations, Faux Bridge in entrance road, all areas will be handicap accessible. The total project value is \$249,873. TP & WT will fund 80% of the project worth \$199,898. The City's 20% portion will be in kind donations of city employee's labor and city equipment. Our match value is \$49,975.

Public Hearing: Angela Sunley with the General Land Office/Beach/Dune Team Leader discusses the Freeport Beach/Dune Plan.

Mayor Pro Tem Norma Garcia opened the Public Hearing at 6:20 p.m. Mr. Pynes stated this was the first step to adopt the Freeport Beach/Dune ordinance. There is a requirement to have a public hearing here and in Austin. Included in this plan is Freeport's lastest annexation and the updated version of the Freeport Beach/Dune Plan.

Joyce Adkins asked if the Bridge Harbor annexation was included the plan. Mr. Pynes stated it was.

Their being no further comments or question, Mayor Pro Tem Norma Garcia closed the Public Hearing at 6:23 p.m.

Public Hearing: Bruce Spitzengel, President of GrantWorks, Inc., discusses the Texas Community Development Block Grant (TxCDBG) Funds, non-housing Disaster Recovery Supplemental (DRS) Program. A requirement of the grant fund, application to rehabilitate the City's Central Lift Station.

Mayor Pro Tem Norma Garcia opened the Public Hearing at 6:23 p.m.

City Manager Jeff Pynes announced that the City of Freeport has been awarded \$554,001 from the Texas Community Development Block Grant (TxCDBG) to rehabilitate the City's central lift station. This public hearing is required for the grant process, to give the public an opportunity to review and provide comments on the proposed application to rehabilitate the City's Central Lift Station. Mr. Pynes felt the central lift station is a good asset to the infrastructure for the community.

Work Session:

Discussion regarding an increase to city wrecker fees and services.

Chief of Police Tyrone Morrow researched the local police departments and sheriff office for fees on non consenting towing. He was approached by one of the wrecking establishments on raising the non consenting towing fees. Our fee is \$85.00 for nonconsent wrecker tow and \$20.00 per day for vehicle storage. The increase cost to maintain a business based on federal and state regulatory requirements have created undo hardship to the wrecking businesses. The consenting towing fee that is being adopted by the surrounding entities is \$130.00 flat fee and \$12.00 for 15 minutes increments, \$20.00 impoundment fee. This request for raising the towing fees is not unreasonable for the wrecker services.

Jeff Crisp owner of J & M Wrecker Service out of Clute, is not on the rotation list and does not have a storage facility in the City, but announces that he can provide a service to the City of Freeport if they get into a bind and if the ordinance was amended. He questioned a wrecker business in Freeport and asked if the establishment was grandfathered. He asked council to research the history.

Mayor Pro Tem Norma Garcia closed the formal agenda and opened the Executive Session at 7:08 p.m.





# ORDINANCE NO. 2010- 226

AN ORDINANCE OF THE CITY OF FREEPORT, TEXAS, AMENDING THE CODE OF ORDINANCES BY ADDING CHAPTER 134, ILLEGAL SMOKING PRODUCTS, TO TITLE XIII, GENERAL OFFENSES, WHICH WILL PROHIBIT THE USE, PURCHASE, POSSESSION, AND SALE OF THE SYNTHETIC CANNABINOID KNOWN OR SOLD UNDER SUCH NAMES AS "K2", "SPICE", "GENIE", "DASCENTS", "ZOHAI", "SAGE", AND "KO KNOCK-OUT 2" AND SALVIA DIVINORUM FOR PUBLIC HEALTH PURPOSES; PROVIDING THAT ANY PERSON VIOLATING SAID CODE, AS AMENDED BY THIS ORDINANCE, SHALL BE GUILTY OF A MISDEMMANOR AND ASSESSED A FINE IN ACCORDANCE WITH THE PROVISIONS OF SECTION 10.99 OF SAID CODE OF ORDINANCES; PROVIDING THAT EACH DAY ANY SUCH VIOLATION CONTINUES AND EACH PART OF ANY DAY ANY SUCH VIOLATION OCCURS SHALL CONSTITUTE A SEPARATE OFFENSE; CONTAINING SAVINGS CLAUSES; CONTAINING A SEVERANCE CLAUSE; AND PROVIDING THAT THIS ORDINANCE SHALL TAKE EFFECT AND BE IN FORCE FROM AND AFTER ITS DESCRIPTIVE CAPTION HAS BEEN PUBLISHED TWICE IN THE BRAZOSPORT FACTS.

WHEREAS, the City of Freeport, Texas, ("the City") is a "Home Rule City" and a "Home Rule Municipality" lying and situated in Brazoria County, Texas, as described in and defined by Section 5, Article XI of the Constitution of Texas and Section 1.005 of the Local Government Code of Texas, respectively; and,

WHEREAS, the City Council of the City has determined that certain businesses within the City may be selling certain substances that when ingested produce intoxicating effects similar to THC or marijuana; and

WHEREAS, the substances identified above are considered to be generally described as synthetic cannabinoids or salvia divinorum distributed, sold and marketed under such names as "K2", "K2 SUMMIT", "K2 SEX", "K2 ULTRA", "K2 BLONDE", "K2 CITRON", "K2 ORISHA", "K2 AMAZONIAN SHELTER", "K2 THAI DREAM", "GENIE", "DASCENTS", "ZOHAI", "SAGE", "SPICE", "K0 KNOCK-OUT 2", "SPICE GOLD", "SPICE DIAMOND", "YUCATAN FIRE", "YUCATAN GOLD", "SOLAR FLARE", "PEP SPICE", "POT-POURRI", "BOMBAY BLUE", "HUSH", "SWERVE", "FIRE N' ICE", AND "SALVIA DIVINORUM"; and

WHEREAS, the substances described above are not yet categorized as illegal controlled substances under state or federal law; and

WHEREAS, the substances described above may be marketed as incense but are commonly being used as an alternative to marijuans which is an identified and documented controlled substance, the sale and use of which is prohibited under the laws of the State of Texas and the United States; and

WHEREAS, the synthetic cannabinoids substances identified above may be presented under a variety of street names but share common ingredients including JWH-018 and JWH-073; and

WHEREAS, salvia divinorum contains the ingredient known as Salvinorin A; and

WHEREAS, these unregulated synthetic cannabinoids and salvia divinorum produce a very potent, intoxicating effect which is estimated by the medical community to produce effects ranging from three :to one hundred times greater and more potent than THC, the active ingredient in marijuana; and

WHEREAS, the substances identified above manifest all of the demonstrated attributes of substances that deprive individuals of judgment, coordination and the ability to conduct themselves in a safe and appropriate manner in modern society; and

WHEREAS, the available medical and law enforcement information on these products indicates that individuals under the effects of these substances may be a clear and present danger to themselves and others; further the long term effects of these substances are not yet known; and WHEREAS, it is anticipated that the Texas Legislature will consider appropriate regulation of these type of commodities in its upcoming legislative session but that it is essential for the municipality to impose some type of reasonable restriction on these products until a state wide regulatory system may be properly implemented; and

WHEREAS, it has been determined that the effects of these substances are a health concern to the citizens of the City; and

WHEREAS, the City Council of the City has determined that it is in the best interest of the public health, safety and welfare to immediately address the health concerns to the citizens of the City by adopting a local ordinance prohibiting the substances identified above;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FREEPORT, TEXAS:

First, that the Code of Ordinances of the City be and the same is hereby amended by adding to Title XIII, General Offenses, a new chapter, to be known as Chapter 134, Illegal Smoking Products, to prohibit the use, purchase, possession, sale and offering for sale of the synthetic cannabinoid known or sold under such names as "K2", "K2 SUMMIT", "K2 SEX", "K2 ULTRA", "K2 BLONDE", "K2 CITRON", "K2 ORISHA", "K2 AMAZONIAN SHELTER", "K2 THAI DREAM", "GENIE", "DASCENTS", "ZOHAI", "SAGE", "SPICE", "K0 KNOCK-OUT 2", "SPICE GOLD", "SPICE DIAMOND", "YUCATAN FIRE", "YUCATAN GOLD", "SOLAR FLARE", "PEP SPICE", "POT-POURRI", "BOMBAY BLUE", "HUSH", "SWERVE", "FIRE N' ICE", AND "SALVIA DIVINORUM", to read as follows:

#### CHAPTER 134. ILLEGAL SMOKING PRODUCTS

#### Sec. 134.01 PURPOSE

The purpose of this article is to prohibit the use, possession, sale, ingestion or smoking of illegal smoking products and ingestion devices hereinafter defined within the city limits of the City of Angleton.

## Sec. 134.02. DEFINITIONS

As used herein, the following words and phrases shall have the following meanings:

"Person" shall mean an individual, corporation, partnership, wholesaler, retailer or any licensed or unlicensed business.

"Illegal smoking product" shall mean any substance, whether described as tobacco, herbs, incense, spice or any blend thereof, regardless of whether the substance is marketed for the purpose of being smoked, which includes any one or more of the following chemicals or a comparable chemical:

- (a) Salvia divinorum or Salvinorin A; all parts of the plant presently classified botanically as salvia divinorum, whether growing or not, the seeds thereof, any extract from any part of such plant, and every compound, manufacture, salts, derivative, mixture or preparation of such plant, its seeds or extracts;
- (b) 2-[(1R, 3S)-3-hydroxycyclohexyl]-5-(2-methyloctan-2-yl) phenol) (also known as CP47, 497) and homologues;
- (c) (6aS, 10aS)-9-(hydroxymethyl)-6, 6-dimethyl-3-(2methyloctan-2-yl)-6a, 7, 10, 10a-tetrahydrobenzo [c] chormen-1-ol) (also known as HU-211 or Dexanabinol);
- (d) 1-Pentyl-3-(1-naphthoyl) indole (also known as JWH-018);
- (e) 1-Butyl-3-(1-naphthoyl) indole (also known as JWH-073);

- (f) 1-pentyl-3-(4-methoxynaphthoyl)indole (also known as JWH-081)
- (g) (6aR, 10aR)-9-(hydroxymethyl)-6, 6-dimethyl-3-(2methyloctan-2-yl)-6a, 7, 10, 10a-tetrahydrobenzo[c]chromen-1-ol (also known as HU-210.

Products containing some of the above substances are currently being marketed under the following commercial names:

"K2", "K2 SUMMIT", "K2 SEX", "K2 ULTRA", "K2 BLONDE", "K2 CITRON",

"K2 ORISHA", "K2 AMAZONIAN SHELTER", "K2 THAI DREAM", "GENIE",

"DASCENTS", "ZOHAI", "SAGE", "SPICE", "KO KNOCK-OUT 2", "SPICE

"DASCENTS", "ZOHAI", "SAGE", "SPICE", "YUCATAN GOLD", "SOLAR

GOLD", "SPICE DIAMOND", "YUCATAN FIRE", "YUCATAN GOLD", "SWERVE",

FLARE", "PEP SPICE", "POT-POURRI", "BOMBAY BLUE", "HUSH", "SWERVE",

"FIRE N' ICE", AND "SALVIA DIVINORUM".

It is anticipated by the City Council that new products will be marketed under different names but such new products will be subject to this definition if they contain any of the chemical components set forth above.

"Ingestion Device" shall mean any equipment, product or material that is used or intended for use in ingesting, inhaling, or otherwise introducing an illegal smoking product into the human body, including:

- (a) a metal, wooden, acrylic, glass, stone, plastic, or ceramic pipe with or without a screen, permanent screen, hashish head, or punctured metal bowl;
- (b) a water pipe;
- (a) a carburetion tube or device;
- (d) a smoking or carburation mask'

- (e) a chamber pipe;
- (f) a carburetor pipe;
- (g) an electric pipe;
- (h) an air-driven pipe;
- (i) a chillum;
- (j) a bong; or
- (k) an ice pipe or chiller.

Sec. 134.03. Sell, Offer, Gift, Display or Possession.

It shall be unlawful for any person to use, possess, purchase, barter, give, publicly display, sell or offer for sale any illegal smoking product.

Sec. 134.04. Use or Possession of Ingestion Devices.

It shall be unlawful for any person to use or possess with intent to use an ingestion device to inject, ingest, inhale or otherwise introduce into the human body an illegal smoking product.

Sec. 134.05. Defense.

A. It shall be a defense to prosecution for a violation of this chapter that any act described in this chapter is under and pursuant to the direction or under a prescription of a licensed physician or dentist authorized to direct or prescribe controlled substances within the State of Texas.

A. It shall be a defense to prosecution under the terms of this chapter if an individual charged with a violation can provide proper and complete historic documentation that the use of such materials is a portion of a religious undertaking or activity of a religious denomination in which they have long standing historic membership supported by documentation from clergy or spiritual leader recognized by the State of Texas.

Second, any person violating the Code of Ordinances of the City of Freeport, Texas, as amended by this ordinance, shall be guilty of a misdemeanor and upon conviction therefor assessed a fine as prescribed in Section 10.99 of said Code; and each day such violation continues and each part of any day any such violation occurs shall constitute a separate offense.

Third, nothing contained in this ordinance shall cause any rights heretofore vested to be altered, affected or impaired in any way and all such rights may be hereafter enforced as if this ordinance had not been adopted.

Fourth, this ordinance is cumulative of and in addition to all other ordinances of the City on the same subject and all such ordinances are hereby expressly saved from repeal. Provided however, where this ordinance and another ordinance conflict or overlap, whichever imposes the more stringent regulations or penalties, as the case may be, shall prevail.

Fifth, no offense committed and no fine, forfeiture or penalty incurred prior to the effective date of this ordinance is to be affected by the adoption of this ordinance but the punishment for any offense committed and the recovery of any fines or forfeitures incurred prior to such date shall take place as if this ordinance had not been adopted.

Sixth, in the event any section or provision of this ordinance is found to be unconstitutional, void or inoperative by the final judgment of a court of competent jurisdiction, such defective provision, if any, is hereby declared to be severable from the remaining sections and provisions of this ordinance and such remaining sections and provisions shall remain in full force and effect.

Seventh, this ordinance shall take effect and be in force from and after the descriptive caption of this ordinance has been published twice in the Brazosport Facts, the official newspaper of the City.

AN ORDINANCE OF THE CITY OF FREEPORT, BRAZORIA COUNTY, TEXAS; AMENDING ITEM (9) OF DIVISION (B) OF SECTION 121.05 OF THE CODE OF ORDINANCES OF SAID CITY TO INCREASE THE AMOUNT OF THE FEE FOR A NONCONSENT WRECKER TOW TO \$130.00; PROVIDING A SEVERANCE CLAUSE; PROVIDING SAVINGS CLAUSES; PROVIDING THAT ANY PERSON VIOLATING ANY PROVISION OF THE CODE OF ORDINANCES OF SAID CITY, AS AMENDED BY THIS ORDINANCE, SHALL BE GUILTY OF A MISDEMEANOR AND PUNISHED AS PROVIDED IN SECTION 10.99 OF SAID CODE; PROVIDING THAT EACH DAY ANY SUCH VIOLATION SHALL CONTINUE OR OCCUR SHALL BE A SEPARATE OFFENSE; AND PROVIDING THAT THIS ORDINANCE SHALL TAKE EFFECT AND BE IN FORCE FROM AND AFTER ITS DESCRIPTIVE CAPTION HAS BEEN PUBLISHED TWICE IN THE BRAZOSPORT FACTS.

WHEREAS, the City of Freeport, Texas ("the City"), is a "Home Rule City" and a "Home Rule Municipality" lying and situated in Brazoria County, Texas, as described in and defined by Section 5, Article XI of the Constitution of Texas and Section 1.005 of the Local Government Code of Texas, respectively; and,

WHEREAS, Sections 54.001 and 54.004 of the Local Government Code of Texas, Paragraphs 2, 3 and 6 of Article 1175 of the Revised Civil Statutes of Texas (1925) and Sections 2.01, 2.02 and Item (k), (p) and (u) of Section 3.07 of the Home Rule Charter of the City authorize the City Council thereof to adopt the provisions of this Ordinance; and,

WHEREAS, the adoption of this ordinance is necessary to the health, safety and general welfare of the inhabitants of the City and persons using the public streets therein.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF FREEPORT, TEXAS:

First, Item (9) of Division (B) of Section 121.05 of the Code of Ordinances of the City is hereby amended to read as follows:

"(9) Not charging more than \$130.00 for a nonconsent wrecker tow or more than \$20.00 per day for vehicle storage without proper authorization from the Chief of Police for unusual accident/incident scene conditions."

Second, any person violating the Code of Ordinances of the City, as amended by this ordinance, shall be guilty of a misdemeanor and upon conviction therefor assessed a fine as prescribed in Section 10.99 of said Code; and each day such violation continues and each part of any day any such violation occurs shall constitute a separate offense.

Third, nothing contained in this ordinance shall cause any rights heretofore vested to be altered, affected or impaired in any way and all such rights may be hereafter enforced as if this ordinance had not been adopted.

Fourth, this ordinance is cumulative of and in addition to all other ordinances of the City on the same subject. Provided however, where this ordinance and another ordinance conflict or overlap, whichever imposes the more stringent regulations or penalties, as the case may be, shall prevail.

Fifth, no offense committed and no fine, forfeiture or penalty incurred prior to the effective date of this ordinance is to be affected by the adoption of this ordinance but the punishment for any offense committed and the recovery of any fines or forfeitures incurred prior to such date shall take place as if this ordinance had not been adopted.

Sixth, in the event any section or provision of this ordinance is found to be unconstitutional, void or inoperative by the final judgment of a court of competent jurisdiction, such defective provision, if any, is hereby declared to be severable from the remaining sections and provisions of this ordinance and such remaining sections and provisions shall remain in full force and effect.

AN ORDINANCE OF THE CITY OF FREEPORT, TEXAS, CONTAINING A PREAMBLE; ADOPTING AND MAKING A PART OF THIS ORDINANCE A DUNE PROTECTION AND BEACH ACCESS PLAN FOR SAID CITY THAT CONTAINS DEFINITIONS, PROVISIONS FOR THE ADMINISTRATION OF SUCH PLAN, REQUIREMENTS FOR DUNE PROTECTION PERMITS, REQUIREMENTS FOR BEACHFRONT CONSTRUCTION CERTIFICATES, CONCURRENT REQUIREMENTS FOR BOTH DUNE PROTECTION PERMITS AND BEACHFRONT CONSTRUCTION CERTIFICATES, PROVISION FOR THE MANAGEMENT OF THE PUBLIC BEACH, MOTOR VEHICLES AND PENALTIES AND GENERAL PROVISIONS AND INCLUDES AN APPENDIX CONTAINING ANNEXATION ORDINANCES OF SAID CITY AND RELEVANT ORDERS OF THE BRAZORIA COUNTY COMMISSIONERS COURT; PROVIDING THAT ANY PERSON VIOLATING AN PROVISIONS OF SUCH PLAN SHALL BE GUILTY OF A MISDEMEANOR AND ASSESSED A FINE NOT TO EXCEED TWO THOUSAND AND NO/100 (\$2,000.00) DOLLARS FOR A VIOLATION OF PROVISIONS FIRE SAFETY, ZONING OR PUBLIC HEALTH AND SANITATION, INCLUDING DUMPING OF REFUSE, AND A FINE NOT TO EXCEED FIVE HUNDRED AND NO/100 (\$500.00) DOLLARS FOR A VIOLATION OF ALL OTHER PROVISIONS OF SUCH PLAN OR THIS ORDINANCE; PROVIDING THAT EACH DAY ANY SUCH VIOLATION CONTINUES AND EACH PART OF ANY DAY ANY SUCH VIOLATION OCCURS SHALL CONSTITUTE A SEPARATE OFFENSE; CONTAINING SAVINGS CLAUSES; CONTAINING A SEVERANCE CLAUSE; AND PROVIDING THAT THIS ORDINANCE SHALL TAKE EFFECT AND BE IN FORCE FROM AND AFTER THIS DESCRIPTIVE CAPTION HAS BEEN PUBLISHED TWICE IN THE BRAZOSPORT FACTS.

WHEREAS, the City of Freeport, Texas, ("the City") is a "Home Rule City" and a "Home Rule Municipality" lying and situated in Brazoria County, Texas, as described in and defined by Section 5, Article XI of the Constitution of Texas and Section 1.005 of the Local Government Code of Texas, respectively; and,

WHEREAS, the Open Beaches Act, codified as Chapter 61 of the Texas Natural Resources Code, and the Dune Protection Act, codified as Chapter 63 of the Texas Natural Resources Code provide for the adoption of a Dune Protection and Beach Access Plan by a municipality which includes a public beach within its territorial limits; and,

WHEREAS, there are included within the territorial limits of the City the public beach known as "Bryan Beach" and a portion of the public beach known as "Surfside Beach"; and,

WHEREAS, the above named beaches have heretofore been governed by the Dune Protection and Beach Access Plan adopted by the Commissioners' Court of Brazoria County, Texas, which has ceded its authority to regulate Bryan Beach and the portion of Surfside Beach included within the territorial limits of the City by Order No. 49 dated April 10, 2007, and Order No. VIII.B.1.c dated June 8, 2010, respectively; and

WHEREAS, the City Council of the City has determined and does here now declare that the adoption of this ordinance adopting a Dune Protection and Beach Access Plan regulating Bryan Beach and the portion of Surfside Beach within the territorial limits of the City is necessary to the health, safety and general welfare of the inhabitants of the City and persons using such beaches.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FREEPORT, TEXAS:

First, the Dune Portion and Beach Access Plan attached hereto and made of part hereof by reference for all intents and purposes is hereby adopted.

Second, any person, firm, corporation or agent violating any provisions of Dune Portion and Beach Access Plan attached hereto shall be guilty of a misdemeanor and, upon conviction, assessed a fine not to exceed Two Thousand and no/100 (\$2,000.00) Dollars for a violation of provisions relating to fire safety, zoning or public health and sanitation, including dumping of refuse, and a fine not to exceed Five Hundred and no/100 (\$500.00) Dollars for a violation of all other provisions of such plan; and each day any such violation continues and each part of any day any such violation occurs shall constitute a separate offense.

Third, no offense committed and no fine, forfeiture or penalty incurred prior to the effective date of this ordinance is to be affected by the adoption of this ordinance but the punishment for any offense committed and the recovery of any fines or forfeitures incurred prior to such date shall take place as if this ordinance had not been adopted.

Fourth, nothing contained in this ordinance shall cause any rights heretofore vested to be altered, affected or impaired in any way and all such rights may be hereafter enforced as if this ordinance had not been adopted.
