OPEN PUBLIC MEETING

The President called the meeing to order at 6:00 o'clock p.m.

PAYMENT OF BILLS:

Upon motion by Director Travis, second by Director Bass, it was VOTED:

DIRECTORS REPORT:

The Director gave a very comprehensive report on the activities of the EDC the past month, with a preview of the various up-coming activities. A copy of this report is attached hereto as Exhibit A and made a part of these minutes.

The President reported on a plant negotiating to locate a \$45 million dollar formal-dehyde plant on a 20 acre tract of the Wong property. The plant would occuply 5 acres and have 25 full time employees.

ELECTION OF VICE PRESIDENT:

The President opened the floor for nominations.

Director Bass nominated Director Trent Allen, seconded by Director Yates.

Director Allen advised, that he would be agreeable to serving.

Upon motion by Director Bass, second by Director Yates it was VOTED:

Director Allen be elected to the office of Vice President of the FEDC.

GORE WATERFRONT PROPERTIES:

Mr Ben Miller, with Coldwell-Banker Realtors, presented a plat depicting the Gore properties on Brazos Blvd which were listed with his company for sale. After general discussion the Board advised that EDC would offer any assistance they may have to locate buyers into the area. Mr Miller provided his copies of the plat which were copied and to be returned by Friday, July 24.

UN-DEVELOPED PROPERTIES IN VELASCO & FREEPORT:

The Administrator advised there were a great number of lots within the Freeport and Velasco townsites, particularly Velasco, that could be obtained by donation or purchase, based on the county appraised value, and asked if the Board thought it advantages to contact the owners regarding acquisition. The Board unanimously agreed to proceed with the project.

BUDGET CONSIDERATIONS:

The Administrator advised that work should begin on the 2015-2016 Budget. The 2014-2015 Budget year will end September 30, 2015. According to the City Finance Director, with a carry-over from last fiscal year \$670.624.07, along with sales tax receipts through June of 2015 in the amount of \$692.644.38, EDC's gross revenue for this fiscal year should exceed \$1,000.000.00. It was requested assistance for preparation of the next year's budget.
