An outline of remaining Christmas events was given: Christmas Colori and Family Movie Night were both scheduled for Dec. 19th. It was suggested by Director Hawkins that going forward any Colori (sidewalk mural drawings) events should expand to include all area schools (as well as those already out of school) and be designed to benefit a different charity every year. Mural spaces would be sold to various companies that want to contribute. Pricing would depend on amount of spaces each entity wants to purchase. It was also suggested by Director Friudenburg that we could get companies to sponsor Christmas trees and decorations for kids to decorate trees with and donate those funds to the library.
