#### 1. OPEN SESSION:

President Sullivan opened the meeting at 5:02 PM. A quorum was present.

#### 2. Welcome New Board Members

President Sullivan welcomed Ms. Girouard as a new member. It was noted by President Sullivan that Ms. Girouard and Ms. Music were previously appointed by the City Council and sworn into their position. It was further noted by Mr. Duncan that both were authorized board members with voting authority.

#### 3. Citizens Comments:

President Sullivan announced the opportunity for any visitors present to address the board. There were no citizen comments.

# 4. Approval of Minutes from December 11, 2018 and January 17, 2019:

**MOTION** made to accept the minutes by Mr. Marquez, Seconded by Mr. Garcia. Motion **PASSED** unanimously.

## 5. Consider payment of bills:

Ms. Hawkins presented and explained itemized bills. Discussion regarding the bill from Catalyst, Wells Nursery, Duncan, and reimbursement to Freeport for wages paid to Hawkins. It was noted that Catalyst had not submitted an invoice yet. Mr. Pena requested that the matter regarding Catalyst be put on a future agenda and considered by the Board. Payment of funds to Catalyst was tabled for future consideration.

**MOTION** to pay the bills presented, excepting Catalyst was made by Mr. Pena, and Seconded by Mr. Marquez. Motion **PASSED** unanimously.

#### 6. Executive Session

MOTION made by President Sullivan to immediately suspend Ms. Hawkins with pay, from her position as Executive Director of the Freeport Economic Development Corporation, and to grant Mr. Kelty, the City Manager of Freeport the authority to take action regarding Ms. Hawkins' employment including but not limited to voluntary or involuntary termination and determine such terms of separation including possible severance or continuation of benefits.

The motion was seconded by Mr. Pena.

Motion **PASSED**, with members, Sullivan, Fruidenberg, Garcia, Marquez, and Pena voting for the motion, and members Girouard and Music abstaining.

## 9. Motion to Adjourn

**MOTION** made by Mr. Marquez to adjourn, seconded by Mr. Garcia. Motion **PASSED** unanimously.
