#### REGULAR MEETING

#### OPEN MEETING

Mr. Barnett opened the regular meeting at 6:00 pm, with all members present except Mingo.

#### CITIZENS COMMENTS

Mrs. Joyce Adkins thought that it would be nice if the Officers names were printed on the agenda like they used to be.

#### APPROVAL OF MINUTES

A motion was made by Mr. Siddall to approve the minutes of 7/14/11 as written, the motion was seconded by Mr. Bass and passed unanimously.

#### PAYMENT OF BILLS

A motion was made by Mr. Siddall to pay both

- a. Joseph A. Fischer & Co. for Appraisal \$700.00 and
- b. Kennemer & Masters 2011 Audit balance \$3203.50

The motion was seconded by Mr. Kouches, and passed unanimously.

It was decided to wait on the money for the Laptop for more clarification.

### ADMINISTRATOR'S REPORT

#### DISCUSS/CONSIDER APPROVAL OF 2011-2012 BUDGET

Mr. Welch was out of town and there was a computer glitch, so Mr. Siddall made a motion to put this item on the next agenda, so everyone would also have a chance to look it over. Mr. Bass seconded the motion and the motion carried unanimously.

# INTRODUCTION OF NEW CITY COUNCIL LIAISION AND NEW BOARD MEMBERS

Mr. Bolton is the new Liaison, but wasn't present. Mrs. Mireles was present in his absence. Mr. Willie Garcia and Mr. Mingo Marquez were announced as the new members to the board, Mr. Garcia was introduced, but Mr. Marquez was not present.

## CONSIDER VFW POST 4341 PROPOSAL FOR BLUES FESTIVAL FUNDS

Mrs. Barnett stated that she was against donating anything to them because one of the other sponsors on the brochure was Eros and she didn't feel that the FEDC should be associated with them. She also didn't think that the girls in bikinis were appropriate either.

Mr. Gilbert said that Eros donated \$10,000 to the Blues Festival last year, that he could only donate \$5000.00 this year because he donated the other \$5000.00 to the City of Freeport's Bryan Beach Bash, and the City accepted the money for a City function. He informed the board that Eros had also donated \$5000.00 to the Museum, which meant that he had donated \$25,000 over the year to the City of Freeport functions.

Mr. Kouches made a motion to put this item on the next agenda, Ms. Diehl seconded the motion. The motion passed, with Mr. Siddall voting no. Mr. Gilbert graciously thanked the board and expressed his gratitude to them whether they decided to donate or not, but invited them to all come and have a good time.
