DIRECTOR'S REPORT

A meeting was held in Angleton with TXDOT and Bio Landscaping concerning the Phase 2 beautification project. The actual amount of material to be removed in order to get to regular soil is proving to be significantly more than indicated in the drawings. This is causing more work on the contractor resulting in more cost. Instructions were given to TXDOT and the contractor calling for an estimate of how much extra cost is involved with the goal of keeping the project cost the same by reducing the extent of the project accordingly.

USACE has informed us that the Port's Birth 5 project had taken up all of their time lately. That is why we don't have the permit for the Trico dock at this time. They indicate that priority will be given to our project in order to expedite the permit. Several weeks will be required to get the materials together for construction of the dock so lack of a permit should not delay the project.
