Finish work on the store and facilities for the dry stack building will be bid because the estimate submitted by Hamilton/Lummus can in about twice what we expected it to cost.

Mark Storey's phase two environmental study has been completed and no contamination was found at the 2100 N. Brazosport site. Mark will soon be closing on the property and working on the development.

Mark Storey has sold the Mesquite Club to the man who owns the 99 Cent store in the Four Corners center. The new owner's plan is to remodel the building and open another 99 Cent store and a cell phone center.

The date scheduled for hearing oral arguments at the 1<sup>st</sup> Court of Appeals has been cancelled and will be rescheduled.

A proposal is being put together by Efren Rodriguez to finish out the Trico building. George Gala has agreed to put off his operations start date until mid July to allow us time to complete the new facilities.
