On a motion by Eddie Virgil, seconded by Royce McCoy, with all present voting "Aye", the minutes of February 3<sup>rd</sup>, and 17<sup>th</sup>, 2015 were unanimously approved.

Discuss/consider making a recommendation to the City Council to schedule a Joint Public Hearing to grant a Specific Use Permit (SUP) to Kimley-Horn and Associates for Verizon Wireless to erect a new 151' High, Monopole, Telecommunication Tower on portion of the property legally described as:

On a motion by Tobey Davenport, seconded by Royce McCoy, with all present voting "Aye", the Planning Commission unanimously approved to schedule a Joint Public Hearing with City Council to consider granting a Specific Use Permit (SUP) to to Kimley-Horn and Associates for Verizon Wireless to erect a new 151' High, Monopole, Telecommunication Tower on portion of the property legally described as:
