Open Meeting

Ms. Diane Williams called meeting to order at 6:00 P.M.

Invocation

Mr. Roddy Mohler opened meeting with prayer.

Approval of Minutes

Mrs. Michelle Kent moved to accept the minutes for February 25, 2008, seconded by Mr. Roddy Mohler, unanimous vote for approval.

<u>Discuss/consider amending the sign ordinance on allowing multi-colored electronic changeable message light emitting diodes (LEDs), in the City and the City's ETJ beginning on June 1, 2008</u>

Mr. Wallace Shaw discussed with the Planning Commission the issues with the multi-colored electronic changeable message light emitting diode's (LEDs), and that they needed to act on it before June 1, 2008, because after that date, there would be no way to control when and where these message boards would go and what would be on them.
